## TERMS AND CONDITIONS OF SALES

- Purchaser authorizes deliveries to be made without signature.** Purchaser specifically agrees to accept our documentation as proof of delivery. Purchaser specifically agrees and accepts sole responsibility for loss after delivery and agrees to indemnify seller against all claims or losses of material after delivery.
- Purchaser agrees to be responsible to verify materials to be correct prior to installation** That are delivered to jobsites or picked by themselves, their agents, or installers, or clients.
- Materials Warranty:** Materials sold as in first class original condition as supplied by Manufacturers. Purchaser agrees to waive all claims of any nature before or after sale, or use of any type, either express, or implied, as to purpose, utility, safety, handability, life span, color, past, present or future potential hazards. **That any and all warranties, if any, are only that available from Materials Manufacturer.**
- Pricing and delivery Costs for materials are priced at time of sale or order place date.** Prices and delivery Charges are always subject to change at any time without notice, unless otherwise specified in writing by CAMCO.
- Return Credit/Refunds , if given, shall be only for regular stocked items** in original unopened packaging, in dry first-class resale condition **Non-stock / Special ordered materials are not accepted for credit or refunds.** Returns may be subject to restocking charges of 20% . Our pickups of materials will be subject to a pick up charge, plus restock fees. Returns of stock items may not be accepted for credit or refunds after 30 days of purchase date.
- Purchaser agrees to pay all invoices by the payment date shown and stated on each invoice.** Normal Terms are Net 30 Days. ***Unless your payments specifically identify invoices to be paid, all payments will be applied:*** (1) first to pay any accrued service charges, (2) the remainder of payment shall be applied against the oldest unpaid invoice(s) or unpaid balances. Credit restrictions may be placed on any past due account without notice. Title and rights to reclaim materials remains with seller until paid in full
- Purchaser agrees to pay Service Charges of 1-1/2 % per month (18 % APR per annum) on balances that that become 30 days past due.** Such charge will appear on your account and on your statements as due.
- Purchaser agrees to immediately examine all invoices and immediately notify CAMCO by certified mail of any disputes or claims...Failure to notify with 10 days shall constitute a waiver of all disputes or claims.**
- If account becomes past due Purchaser agrees to pay all costs necessary to secure payment(s)** including property title searches, lien costs, legal filing fees, collection agencies fees, reasonable attorney fees, court costs, plus interest at 18% per annum from date of invoice, plus any other incurred expenses incurred to secure payment.
- Liens or Non Payment Notices may be effected any time after any sales invoice becomes past due over 30 days.** *(If State Laws require a Notice of Lien or Payment Right Reservations prior to delivery, we may deliver Or file such notice with delivery or before delivery )*
- On Direct Factory shipment or Jobsite Shipments purchaser agrees to** (1) Unload trucks within 2 hours of arrival to avoid demurrage charges (2) To note any shortages or damages to materials on Carrier's dray bill, have Driver sign, then provide a copy immediately to CAMCO. If not done purchaser waives all claims for such loss. That CAMCO cannot be responsible for any loss caused by any delays by Shipper or Common Carrier deliveries.
- All parties specifically agree voluntarily to waive all rights to jury trials** in any suits, actions, claims, proceedings, debts, or counterclaims under this contract or related sales contracts between parties.

# PERSONAL GUARANTY AGREEMENT

In consideration of extension of credit by CAMCO ROOFING SUPPLIES, INC. (CAMCO) P.O.Box 34548, Memphis, TN 38184-0548, the undersigned does hereby unconditionally guarantee payment of whatever amount of credit applicant shall at any time be now existing or hereafter arising to on account of goods and material hereafter delivered, furnished, or supplied, whether said indebtedness is in the form of notes, bills or open account. This shall be an open and continuing guaranty and shall continue in force notwithstanding any change in the form of such indebtedness, or renewal or extensions granted by the CAMCO, without obtaining any consent thereto, and until expressly revoked by written notice from me to you by certified mail and any such revocation shall not in any manner affect my liability as to any indebtedness contracted prior to receipt of notice.

The undersigned Guarantor(s) further agrees to pay all related lien costs, collection expenses, including court cost, reasonable attorney fees, interest at the annual rate of 18%, plus any collection agency fees/costs incurred by the Company in the collection of any or all amounts owed by them by the Credit Applicant or in enforcing this guaranty agreement. This guaranty shall be a continuing, absolute and unconditional guaranty and shall be enforceable by CAMCO ROOFING SUPPLIES, INC.

All diligence in collection, protection, all presentment, demand, protest and/or notice as to anyone or everyone, of dishonor and default and of nonpayment and of the creation and existence any and all guaranteed debts and any and all extensions of credit and indulgence hereunder, are expressly waived.

That parties knowingly, voluntarily and specifically waive any right to a trial by Jury in any suit, action, claim, proceeding or counterclaims concerning this agreement, or in any suit, proceeding, claims or counterclaims related in any manner to any material supplied, and specifically agree all matters or issues shall be tried only before a Judge. This provision is a material inducement for CAMCO ROOFING SUPPLIES, INC to enter into this agreement.

The liability of the undersigned Guarantor shall be joint and several. Payment from the Guarantor(s) of monies due and owing as a result of this guaranty agreement shall be due upon demand by CAMCO ROOFING SUPPLIES, INC.
